I understand the risks inherent in said Activity, which may include bodily injury, death or property damage to myself or my canine.

In consideration of my use of the equipment and facilities provided by Canine Karma, I do hereby fully and forever release, waiver, and discharge Canine Karma, its agents or employees, (collectively referred to as "Canine Karma"), from and against any and all liability for any harm, injury, damage, claims, demands, actions, causes of action, costs and expenses of any nature which I or my canine may have or which may hereafter accrue to Participant, arising out of or related to any loss, damage or injury, including but not limited to suffering and death, that may be sustained by Participant or by any property belonging to Participant, whether caused by the negligence or carelessness of Canine Karma, or otherwise, while Participant is in, on, upon, or in transit to or from the premises where the Activity, or any adjunct to the Activity, occurs or is being conducted. I, the owner or guardian of Participant, assume all responsibility for behavior and actions of Participant. Should any behavior on the part of the Participant, now or in the future, result in damage to property, owner or third party, I hereby agree to assume full responsibility and liability to such third party for any such damage and absolve Canine Karma for any and all damage or injuries to third parties. It is my express intent that this release shall bind the members of Participant's family, estate, heirs, administrators, personal representatives or assigns.

I understand and agree that Canine Karma may not have medical personnel available at the location of the Activity. We understand and agree that Canine Karma is granted permission to authorize emergency medical treatment, if necessary, and that such action by Canine Karma shall be subject to the terms of this Agreement. We understand and agree that Canine Karma assumes no responsibility for any injury or damage, which might arise out of or in connection with such authorized emergency medical treatment.

By signing this Release, I acknowledge that I have reviewed and understand what the above means and that this document is signed as a free act and of my own volition. No oral representations, statements or inducements, apart from the foregoing written statement have been made. I further state that there are no health-related reasons or problems which preclude or restrict the Participant's participation in this Activity, and that Participant has adequate health insurance necessary to provide for and pay any medical costs that may be attendant as a result of injury to Participant. We further agree that this Release shall be construed in accordance with the laws of the State of Ohio.

By signing below, I state that I am fully competent to sign this Release and that I execute this Release for full, adequate and complete consideration fully intending for myself, for my canine and for any family, estate, heirs, administrators, personal representatives, or assigns to be bound by the same.
